- C. Shop Drawings: Submit shop drawings showing layout, profiles, and product components, including anchorage, accessories, finish colors, patterns, and textures.
- D. Samples: Submit selection and verification samples for finishes, colors, and textures.
- E. Quality Assurance Submittals: Submit the following:
 - 1. Certificates: If required, certification of performance characteristics specified in this document shall be provided by the manufacturer.
 - 2. Manufacturer's Instructions: Manufacturer's installation instructions.
